Having regard to decree n° 74-499 dated 27 April 1974, relating to the system of old-age, disability and survivors pensions in non agricultural sector, all amending or completing texts and notably decree n° 94-1429 dated 30 June 1994 and particularly article 18.

Orders the following :

Article one – Wages serving as the basis for calculating old-age, disability and survivors pensions granted within the framework the aforementioned decree n° 74-499 dated 27 April 1974, are updated according to the following scale :
