

Decree-law n° 2011-16 dated 26 March 2011, relating to the national employment fund.

Issues the following decree-law:

Article one - Shall be amended the provisions of paragraph 3 of article 13 of law n° 99-101 dated 31 December 1999, relating to the appropriations law for the year 2000 as follows:

-The Minister charged of employment is the person who has the power to authorize expenditure to the national employment fund.

The expenses of this fund have an evaluative nature.

Art. 2 - The decree-law herein shall be published in the Official Gazette of the Republic of Tunisia.
