Having regard to decree n° 2005-1707 dated 6 June 2005, fixing the attributions of the Ministry of Culture and Heritage Preservation,

Having regard to decree n° 2006-370 dated 3 February 2006, fixing the procedures and methods of compulsory consultation of the Competition Council on the draft regulations,

Having regard to the order of the secretary of state to cultural affairs and orientation dated 29 April 1964, fixing the conditions of delivery and withdrawal of the professional identity card in the field of cinema, as completed by the order dated 5 April 1983 and amended by the order dated 21 April 1995,

Having regard to the order of the secretary of state to cultural affairs and orientation dated 29 April 1964, fixing the composition of cinematographic programs and the conditions of lease and distribution of films, as amended by the order dated 23 May 1981 and by the order dated 5 September 1984,

Having regard to the order of the Minister of Cultural Affairs dated 23 May 1981, relating to the criteria of theatres classification,

Having regard to the order of the Minister of Cultural Affairs dated 23 May 1981, fixing the conditions and rules of grant of the aid to the exploitation of the Tunisian movies, movies for children and classified movies (art and essay), as amended by the order dated 26 September 1981,

Having regard to the order of the Ministers of National Economy and of Cultural Affairs dated 23 May 1981, fixing the prices of theatres places,

Having regard to the order of the Ministers of National Economy and of Cultural Affairs dated 23 May 1981, relating to the investments incentives as regards building or extension of cinematographic theatres,

Having regard to the order of the Prime Minister dated 2 November 2000, fixing the sample of single statement to the establishment of individual projects,

Having regard to the opinion of the Competition Council.

Orders the following :

Article one - The specifications relating to the establishment and exploitation of a cinematographic theatre with commercial nature annexed to the order herein are approved.

Art. 2 - Any person wishing to establish a cinematographic theatre with commercial nature shall, before starting his activities, sign the specifications approved by the order herein and comply with all their provisions.

The cinematographic theatres owners with commercial nature opened before the order herein comes into effect shall regularize their situations within a deadline

not exceeding one year as of the aforesaid date, with signing the specifications, complying with all their provisions and lodging them to the relevant regional commissionership of the Ministry in charge of culture.

Art. 3 - The order herein shall be published in the Official Gazette of the Republic of Tunisia.
