Decree n° 2009-3692 dated 7 December 2009, completing decree n° 2004-519 dated 9 March 2004, establishing a tax on the export of cast iron, iron and steel scraps.

The President of the Republic,

On a proposal from the Minister of Finance,

Having regard to law n° 70-66 dated 31 December 1970, relating to the appropriations for the year 1971 and notably article 48,

Having regard to law n° 89-113 dated 30 December, 1989, relating to the application of a new import customs duties tariff, as amended and completed by subsequent texts and notably by law n° 2008-77 dated 22 December 2008 relating to the appropriations for the year 2009,

Having regard to the investments incentive code promulgated by law n° 93-120 dated 27 December 1993, as amended by subsequent texts and notably law n° 2009-5 dated January 26 2009,

Having regard to the customs code promulgated by law n° 2008-34 dated 2 June 2008,

Having regard to decree n° 75-316 dated 30 May 1975, fixing the attributions of the Ministry of Finance,

Having regard to decree n° 2004-519 dated 9 March 2004, establishing a tax on the export of cast iron, iron and

steel scraps, as amended by decree n° 2008-2399 dated 23 June 2008,

Having regard to the opinion of the Minister of Trade and Handicrafts,

Having regard to the opinion of the Minister of Industry, Energy and Small and Medium-Sized Enterprises,

Decreases the following :

Article one - Is added to article 2 of decree n° 2004-519 dated 9 March establishing a tax on the export of cast iron, iron and steel scraps, as amended and completed by subsequent texts what follows:

Are also exempted from the tax provided for in article one of the decree herein, the products listed in the positioning number 72.04 of the customs duties tariff acquired from the local market by the totally exporting companies exercising in the foundry sector and realizing a high value added and this on the basis of annual program of use approved by the departments of the Ministry of Industry, Energy and Small and Medium-Sized Enterprises.

Art. 2 - The Minister of Finance, the Minister of Trade and Handicrafts and the Minister of Industry, Energy and Small and Medium-Sized Enterprises shall, each in his respective capacity, implement the decree herein which shall be published in the Official Gazette of the Republic of Tunisia.
