

**Decree n° 2009-2752 dated 28 September 2009, completing decree n° 94-539 dated 10 March 1994, fixing the premiums, the lists of activities and the collective projects of infrastructure and equipments eligible to the encouragements for the regional development.**

The President of the Republic,

On a proposal from the Minister of Development and International Cooperation,

Having regard to law n° 73-82 dated 31 December 1973, relating to the finance law for the year 1974 and notably article 45 relating to the creation of the industry promotion and decentralization fund,

Having regard to the investments incentive code promulgated by law n° 93-120 dated 27 December 1993, as amended and completed by subsequent texts and notably law n° 2009-5 dated 26 January 2009 completing the investments incentive code,

Having regard to decree n° 78-578 dated 9 June 1978, reviewing the regulation of the industry promotion and decentralization fund, as amended and completed by subsequent texts and notably decree n° 2008-386 dated 11 February 2008,

Having regard to decree n° 94-492 dated 28 February 1994, fixing the lists of the activities concerned by the sectors provided for by articles 1, 2, 3, and 27 of the investments incentive code, as amended and completed by subsequent texts and notably decree n° 2008-3961 dated 30 December 2008,

Having regard to decree n° 94-539 dated 10 March 1994, fixing the premiums, the lists of activities and the collective projects of infrastructure and equipments eligible to the encouragements for the regional development, as amended and completed by subsequent texts and notably decree n° 2009-1501 dated 18 May 2009,

Having regard to decree n° 96-270 dated 14 February 1996, fixing the attributions of the Ministry of economic development, as amended and completed by decree n° 96-1225 dated 1<sup>st</sup> July 1996,

Having regard to decree n° 99-483 dated 1<sup>st</sup> March 1999, delimiting the regional development encouragement zones, as amended and completed by subsequent texts and notably decree n° 2008-387 dated 11 February 2008,

Having regard to decree n° 2008-388 dated 11 February 2008, encouraging the new promoters, small and medium-sized enterprises, the small enterprises and the small trades, as amended and completed by decree n° 2009-36 dated 13 January 2009,

Having regard to the opinion of the Minister of Finance, the Minister of Environment and Sustainable Development,

the Minister of Industry, Energy and Small and Medium-Sized Enterprises, the Minister of Communication and Relations with the Chamber of Deputies and the Chamber of Advisors and the Minister of Culture and Heritage Preservation,

Having regard to the opinion of the Administrative Court.

Decreases the following:

Article one - Is added to the list of services activities fixed by annex n° 2 of decree n° 94-

539 dated 10 March 1994 referred to above, which follows:

- Activities of cultural production and industries:

Production Multi-media supports with cultural content,

Digitalization and cataloguing of the material cultural heritage,

Digitalization and cataloguing of audio-visual fund.

- Services of environment protection:

cleansing, purification and re-use of waste water,

water treatment.

- Services of studies, counseling, expertise and assistance:

laboratories of ground and water analysis.

- Other services:

printing and reproduction of plans,

water desalination.

Art. 2 - The Minister of Development and International Cooperation, the Minister of Finance, the Minister of Environment and Sustainable, the Minister of Industry, Energy and Small and Medium-Sized Enterprises, the Minister of Communication and Relations with the Chamber of Deputies and the Chamber of Advisors and the Minister of Culture and Heritage Preservation shall, each in his respective capacity, implement the decree herein which shall be published in the Official Gazette of the Republic of Tunisia.
