**Decree n° 2009-2751 dated 28 September 2009,
amending and completing decree n° 94- 492 dated
28 February 1994, fixing the lists of the activities
concerned by the sectors provided for by articles
1, 2, 3 and 27 of the investments incentive code.**

The President of the Republic,

On a proposal from the Minister of Development and
International Cooperation,

Having regard to the investments incentive code promulgated by law n° 93-120 dated 27 December 1993, as amended and completed by subsequent texts and notably law n° 2009-5 dated 26 January 2009 completing the investments incentive code,

Having regard to decree n° 94-492 dated 28 February 1994, fixing the lists of the activities concerned by the sectors provided for by articles 1, 2, 3, and 27 of the investments incentive code, as amended and completed by subsequent texts and notably decree n° 2008-3961 dated 30 December 2008,

Having regard to decree n° 96-270 dated 14 February 1996, fixing the attributions of the Ministry of economic development, as amended and completed by decree n° 96-1225 dated 1st July 1996,

Having regard to decree n° 98-793 dated 4 April 1998, relating to the private medical establishments, as amended and completed by decree n° 2009- 1926 dated 15 June 2009,

Having regard to decree n° 98-795 of April 4, 1998, fixing the conditions of creation and operation of the hemodialysis centers, as amended and completed by subsequent texts and notably decree n° 2009- 1927 dated 15 June 2009,

Having regard to the opinion of the Minister of Finance, the Minister of Public Health, the Minister of Industry, Energy and Small and Medium-Sized Enterprises, the Minister of Communication and Relations with the Chamber of Deputies and the Chamber of Advisors and the Minister of Culture and Heritage Preservation,

Having regard to the opinion of the Administrative Court.

Decreases the following:

Article one - Is repealed, the second dash of point 6 " health " of paragraph III " services " provided for by the list of activities according to sectors annexed to decree n° 94-492 dated 28 February 1994 referred to above and replaced by what follows:

- Centers of healthcare and rehabilitation.

Art. 2 - Are added to the paragraph III " services " of the list of activities concerned by the sectors annexed to decree n° 94-492 dated 28 February 1994 referred to above, the following activities:

7. Activities of cultural production and industries

- Production Multi-media supports with cultural content,
- Digitalization and cataloguing of the material cultural heritage,

- Digitalization and cataloguing of audio-visual fund.

Art. 3 - The Minister of Development and International Cooperation, the Minister of Finance, the Minister of Public Health, the Minister of Industry, Energy and Small and Medium-Sized Enterprises, the Minister of Communication and Relations with the Chamber of Deputies and the Chamber of Advisors and the Minister of Culture and Heritage Preservation shall, each in his respective capacity,

implement the decree herein which shall be published in the Official Gazette of the Republic of Tunisia.
